The following instructions are meant to assist you in filling out the application correctly. Please fill out, sign, and date <u>ALL</u> necessary fields. Incomplete applications will **NOT** be accepted.

**Document Checklist:** Director of Training will complete this checklist

Data Privacy Notice: Applicant checks 'YES' or 'NO'

<u>Applicant Information:</u> If you have an SSPC/AMPP ID please include that in the space provided. Course date will be completed by Director of Training. Please complete personal <u>AND</u> employer information.

<u>Professional References:</u> Applicant must provide three professional references. These are individuals who can verify that the applicant has Industrial Coating experience and one <u>MUST</u> be a supervisor. Please include at least one email

**Prerequisite Information:** Applicants will be using process B

**Exam Checklist:** If you are currently CAS Level 2 Interim certified, only check the **WRITTEN EXAM**. If you are NOT currently certified in CAS Level 2 Interim or Full Status, check **WRITTEN EXAM**, **HANDS-ON BLASTER EXAM**, **AND HANDS-ON SPRAYER EXAM** 

<u>Work Experience:</u> Please read the directions for this section. Applicant <u>MUST</u> include types of blasting, types of surface prep, types of coatings, and types of structures worked on in the **RESPONSIBILITIES** section. Applications will be rejected without at least on example of each. Applicants <u>MUST</u> also fill out one section for each contractor they have worked for going back at least 6,000 hours with dates of employment and approximate hours

<u>Training History:</u> Feel free to add any formal training you may have, but is not necessary if you have the 6,000 work hours.

SSPC Trainthepainter (TTP): Please mark 'YES' or 'NO'

<u>Job Description/Duties:</u> Please fill out name, contractor, title, dates of employment, and approximate hours. Check boxes next to everything you have done with that contractor. Sign and date. There should be one of these pages for each contractor you have worked with for the past 6,000 hour requirement and should correspond to each employer you listed in the WORK EXPERIENCE section.
